• Fund under Article 6 Regulation (EU) 2019/2088 - Funds that do not focus on sustainability.

• Fund under Article 8 Regulation (EU) 2019/2088 - aims to promote certain environmental and social objectives, but does not have as its primary objective investing in sustainable companies and countries.

• Fund under Article 9 Regulation (EU) 2019/2088 - the Fund aims to promote the achievement of certain environmental and social objectives, but has as its main objective to invest in companies and countries whose activities or objectives are related to sustainability.

What is the EU Taxonomy?

The EU Taxonomy is a classification system for environmentally sustainable economic activities and is integrated in Regulation (EU) 2019/2088, in particular in Article 8 or Article 9, as they cover environmentally and/or socially sustainable investments. **It will make a minimum share of sustainable investments with an environmental objective of 95% in economic activities that do not qualify as environmentally sustainable according to the EU Taxonomy.
